## Functions of Anti Ragging Committee:

- 1) To comply the requirements of the National ragging prevention programmes and monitor the online submission of affidavits and to obtain undertaking cum declaration on the prescribed format for prevention of ragging and to say to No to Ragging.
- 2) To ensure compliance with the provisions of these Regulations and any law for the time being in force concerning ragging and to deal and act promptly with the incidents of ragging brought to its notice.
- 3) To keep tabs on the happenings /events related to ragging in Campus or Off-campus within the hostels and other designed places in the premises.
- 4) To conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses to place before it the facts, documents and views concerning the incident of ragging, and considering such other relevant information as may be required.
- 5) To monitor, direct and oversee the functions and performance of the Anti-Ragging Squads in prevention
- 6) To organise counselling sessions for seniors and fresher's separately to sensitise about the serious draw backs and legal consequences of ragging and to invite a support to prevent ragging by all means.
